# 3. ADMINISTRATION RESOLUTION NUMBER: 2025-04-071 3.1 ADOPTION OF BY-LAW NUMBER 470-2025 DECREEING THE REPAIR OF CULVERT NUMBER 5038 ON GLEN ROAD AND AUTHORIZING A LOAN IN THE AMOUNT OF \$464,130.45 TO COVER THE COST

**WHEREAS** Council considers it a priority to proceed with the repair of culvert number 5038 on Glen Road (see the 2025 Three-Year Plan);



No de résolution ou annotation **WHEREAS** the cost of this work is estimated at \$464,130.45, including net taxes, professional fees, contingency costs and financing costs;

**WHEREAS** this work is supported by a subsidy from the Local Road Assistance Program – Recovery Component, as is apparent from a letter from the Minister of Transport and Sustainable Mobility dated January 10, 2025, attached to this By-law to form an integral part thereof as Schedule B;

WHEREAS a loan by-law whose purpose is to carry out the work and repay the loan, which is entirely borne by owners of immovables throughout the territory of the municipality, is subject only to the approval of the Minister of Municipal Affairs and Housing;

**WHEREAS** a loan by-law of which at least 50% of the planned expenditure is through a subsidy the payment of which is guaranteed by the Government or by one of its ministers or agencies is subject only to the approval of the Minister of Municipal Affairs and Housing;

**WHEREAS** a notice of motion under this by-law was duly given at the special Council meeting held on May 26, 2025;

WHEREAS a draft by-law was tabled at the same meeting;

**WHEREAS** the amount of the expenditure decreed by this by-law as well as the methods of financing, payment and reimbursement were outlined before the adoption of the by-law;

**THAT** Council adopts by-law number 470-2025 in the amount of \$464,130.45 decreeing the repair of culvert number 5038 on Glen Road and authorizing a loan to cover the cost.
