REGULATION RESPECTING THE APPLICATION OF THE ACT TO PROMOTE THE PROTECTION OF PERSONS BY ESTABLISHING A FRAMEWORK WITH REGARD TO DOGS – INTENT TO DECLARE AND ORDER

WHEREAS on April 12, 2023, an incident involving a dog took place in West Bolton;

WHEREAS the incident resulted in two bites on a worker performing work on his client's property;

CONSIDERING the recommendations listed in the report of Dr. Nathalie Therrien, the veterinarian who conducted the behavioural assessment of the dog on May 18, 2023;

CONSIDERING the information recorded in the employee's medical report regarding bites and required treatments.

IT WAS MOVED BY: Gilles Asselin SECONDED BY: Marie-Blanche Richer AND RESOLVED:

To submit a Notice of Intent:

- Declaring the dog potentially dangerous;
- Ordering the owner of the dog to comply with the following mandatory measures and conditions:
 - Follow up with the attending veterinarian at his expense in order to initiate, if necessary, pharmacological treatment to treat the dog's anxiety;
 - Install at his expense a sign visible from the public road notifying visitors of the presence of a potentially reactive dog.
 - Outside the property, ensure that the dog wears a head or body harness and is kept on a leash at all times by a responsible adult able to control the dog and who has been informed of the dog's conditions of custody. The leash used must be less than 1.25m and must not be retractable;
 - Not let the dog welcome visitors freely, even on his property;
 - Be on the lookout for signs of anxiety and remove the dog from the situation if necessary;
 - Perform exercises to desensitize the dog to strangers as well as unusual noises;
 - Ensure that the dog wears a yellow scarf outside the property to warn others that it is a possibly reactive dog;
 - Upon request, be able to produce proof of vaccination of the dog against rabies and the vaccination must be kept up to date.

The owners have ten (10) days to produce any additional documentation and/or express their intention to represent themselves before Council to challenge the measures and conditions presented in the intent to declare and order. At the end of these ten (10) days, the corrective measures will be considered accepted. These will take full effect following a resolution at the regular sitting of July 10, 2023.
