#### **ADMINISTRATION** 7.11. REQUEST FOR SUPPORT – SAFE AND COMPLETE RETURN OF ROADSIDE **ENFORCEMENT ACTIVITIES IN QUEBEC RESOLUTION NUMBER: 2025-09-133**

WHEREAS Quebec's highway controllers play an essential role in public safety, in particular by ensuring the surveillance of heavy vehicles, compliance with standards for the transportation of hazardous materials, speed enforcement operations, and the safety of school and passenger transportation;

WHEREAS since the decision rendered on March 6, 2025, by the Administrative Labour Tribunal (TAT), a significant portion of the activities of highway controllers has been suspended or greatly reduced, in particular due to the restriction of these officers to checkpoints (weighbridges);

WHEREAS this limitation directly affects the ability of highway controllers to intervene preventively and effectively in the field, thus increasing the risk of accidents related to non-compliant heavy vehicles, inadequate transportation of hazardous materials, overloading, mechanical wear or driver fatigue;

WHEREAS the summer period and the start of the school year are critical times on the road network due to heavy traffic, the transportation of tourists and the surge of school buses carrying children;

WHEREAS the Government of Quebec's inaction since the ALT's ruling is troubling, and concrete measures are necessary to restore the full intervention capacity of highway controllers;

WHEREAS road safety is a shared responsibility between the levels of government, and whereas municipalities are committed to the safety of their citizens;

**THAT** the Municipality of West Bolton supports the request to the Government of Quebec to immediately review the decision rendered by the Administrative
