TO PERSONS INTERESTED IN THE SECOND DRAFT BY-LAW NO. 478-2025 ON THE MAINTENANCE AND OCCUPANCY OF BUILDINGS

PUBLIC NOTICE is hereby given by the undersigned of the following:

1. At a meeting held on February 9, 2026, the Council of the Municipality of Bolton-Ouest adopted the first draft of By-law No. 478-2025 on the maintenance and occupancy of buildings;
2. A public consultation meeting will be held on Monday, March 9, 2026, at 7:30 p.m. in the municipal council chamber at Town Hall, located at 9 Town Hall Road in Bolton-Ouest. During this public meeting, the Mayor or a person designated by the Mayor will explain the draft by-law and the impacts of its adoption, and will hear from individuals and organizations wishing to express their views on the subject. Those who wish to do so may submit written comments, briefs, or statements until Monday, March 16, 2026;
3. The purpose of the draft by-law is, in particular, to regulate the maintenance and occupancy of buildings in order to protect the cultural heritage of the built environment;
4. This draft applies to all buildings within the territory of the Municipality of Bolton-Ouest;
5. This draft does not contain any provisions subject to referendum approval;
6. This draft by-law may be consulted at Town Hall, located at 9 Town Hall Road, Bolton-Ouest, Tuesday through Thursday between 8:30 a.m. and 12:00 p.m. and between 1:00 p.m. and 4:00 p.m., or by appointment on Mondays and Fridays. It is also available on the municipality's website;
