3. If more than one person wishes to be a candidate for the same seat, you may exercise your voting right by going to your assigned polling station on the following dates and hours.

Polling day: **Sunday October 25th, from 10 a.m. to 8 p.m.**

Advance polling day: **Sunday October 18th, from 12 p.m. to 8 p.m.**

Other advance polling day: **Friday October 16th from 4 p.m. to 8 p.m.** and **Tuesday October 20th from 4 p.m. to 8 p.m.**

If you are unable to move about for health reasons and are registered on the list of electors as a domiciled person, you may ask your returning officer until **October 13th** to vote in your room located in a recognized health care facility or in your home. The same applies to your caregiver.
